### **Doggy Daycare General Information and Polices**

The purpose of Canine-To-Five program is to provide a safe, fun and stimulating social environment for dogs during weekday business hours. To ensure the safety and health of your pet and other guests, we require all guests to comply with the following rules and regulations:

**Age:** All dogs must be at least 6 months of age or older.

**Sex:** All dogs 6 months or older must be spayed or neutered.

**Shots:** All dogs must have up-to-date vaccinations. Owners must submit written proof of Rabies, DHLPP and Bordetella vaccinations.

**Health:** All dogs must be in good health. Owners will certify that their dog (s) are in good health and have not been ill with a communicable condition in the last 30 days. Upon admission, all dogs must be free from any condition which could potentially jeopardize other guests. Dogs that have been ill in the last 30 days will require a veterinarian certification of health to be admitted or readmitted.

**Behavior:** All dogs must be non-aggressive and not toy protective. Owners will certify their dogs have not harmed or shown any aggressive or threatening behavior towards any person or any other dog (s). Please remember: your pet will be spending time with other pets and the safety and health of all animals is our main concern.

**Applications:** All attendees must complete a daycare registration form and questionnaire. Please remember to sign and date the contract at the end. This application may be turned in the day of daycare or beforehand.

**Days and Hours:** Monday through Friday from 8:00a.m. thru 5:30p.m. Must have confirmed reservation before dropping off a pet.

**Reservations:** Required. Cancellations with less than 24 hours notice may be charged the full fees.

Fees: Fees are based on scheduled daycare reservations or boarding guest (s) sign-up.

Days and Hours: Monday thru Friday from 7:00 a.m. - 6:00 p.m. Reservations and drop off appointments are required. Failure to provide 24 hour advance notice of cancellation may cause full fees to be charged.
