This is an Agreement between Countryside Bed & Biscuit For Pets Ltd., and the pet owner whose signature appears below (hereinafter called "Owner").

- 1. Owner agrees to pay the rate for pet care provided in effect on the date pet is checked into the Kennel.
- 2. Owner further agrees to pay all costs and charges for special services requested, and all veterinary costs for the pet during the period said pet is in the care of the Kennel.
- 3. Owner further agrees that the pet shall not leave the facility until all charges due are paid by Owner or proper payment arrangements are agreed upon by both parties.
- 4. Owner also acknowledges there is a \$25.00 charge for any returned check that is submitted to the Kennel for payment, further more the Owner will no longer be allowed to write a check to the Kennel and must provide the Kennel with an approved credit card number for billing purposes.
- 5. By signing this Agreement and leaving pet with the Kennel, Owner certifies to the accuracy of all information given about said pet. The Kennel reserves the right to deny admittance to Owner's pet for any reason at any time.
- 6. The Kennel shall exercise reasonable care for the pet delivered by the Owner to the pet care provider. If interactive daycare is provided, Owner recognizes and accepts potential risks involved in such activity. It is expressly agreed by Owner and pet care provider that the kennel's liability shall in no event exceed the lesser of the current chattel value of a pet of the same species or the sum of \$400.00 per animal admitted. The Owner further agrees to be solely responsible for any and all acts or behavior of said pet while it is in the care of the pet care provider, to include payment of costs for injury to staff or other animals or damage to facilities caused by the pet.
- 7. Owner specifically represents that he or she is the sole owner of the pet, free and clear of all liens and encumbrances.
- 8. Owner specifically represents to the Kennel that, to Owner's knowledge, the pet has not been exposed to any contaglous diseases within a thirty-day period prior to checking in. During the period of this Agreement, Owner also agrees to notify the Kennel of any known exposure of pet to a communicable disease and hold pet out of attending the Kennel until pet is symptom free for a minimum of (30) days or with written veterinary clearance. Owner further agrees to maintain currency of vaccinations as required by Kennel policy. The Kennel requires all canines to have proof of Rabies, Distemper, and Bordetella (Canine Cough) Vaccines. Felines are required to have Rabies, Distemper, and the Feline Leukemia vaccine or a negative test.
- 9. All Charges incurred by Owner shall be payable upon pickup of pet, or when billed by the kennel at address listed on contract. The Kennel shall have, and is hereby granted, a lien on the pet for any and all unpaid charges resulting from services provided by the Kennel. The Owner hereby agrees that in the event the charges are not paid when due in accordance with this contract, the Kennel may exercise its lien rights upon thirty days written notice given by the Kennel to Owner by certified mail to address shown on contract.
- 10. If pet becomes ill or injured, or if the state of the animal's health otherwise requires professional attention, the Kennel, in its sole discretion, may engage the services of a veterinarian or administer medicine or give other requisite attention to the animal, and the expenses there of shall be paid by the Owner.
- 11. This Agreement contains the entire agreement between the parties. All terms and conditions of this Agreement shall be binding on the heirs, administrators, personal representatives and assigns of the Owner and the Kennel.
- 12. Any controversy or claim arising out of or relating to this Agreement, or the breach thereof, or as the result of any claim or controversy involving the alleged negligence by any party to this Agreement, shall be settled in accordance with the rules of the American Arbitration Association, and judgment upon the award rendered by an arbitrator may be entered in any Court having jurisdiction thereof. The arbitrator shall, as part of the award, determine an award to the prevailing party of the costs of such arbitration and reasonable attorney's fees of the prevailing party.
